Background information: At this time, this account is to be used for the cash flow accounting instrument for the 7th grade class trip to the Renaissance Faire. A 7th grade student will be designated to sign as student treasurer at the beginning of the 2012-13 school year. The Class of 2018 will not hold official class status until grade 9 and therefore there will be no advisor in place until that time.		
7.	Approve submission of delinquent Per Capita tax in the amount of \$ to Statewide Tax Recovery. Background information: April 30, 2012 was the deadline for per capita payments under the penalty period. A complete list of the filing can be obtained from the Director of Business Affairs.

The assessed value reduction that must appear on each tax notice as a homestead exclusion for each approved homestead is \$5,788, which is an increase of \$49 from 2011-12. The real estate tax reduction amount applicable to each approved homestead for 2012-13 is \$165.36.
